Scope of Construction Activity:

AWH shall install construction entrances, site clearing, utility relocations and billboard removal in the DART Silver Line guideway from the Elm Fork of the Trinity River East towards Stemmons Freeway (I-35 Express).

The scope of work shall be as follows:

1. AWH shall install guideway haul roads at multiple locations along the guideway (EXHIBIT 1 attached). The haul road process involves stripping topsoil, soil compaction, installation of additional base, and a proof roll for testing.
2. AWH shall install construction entrances/guideway access-points along the guideway (EXHIBIT 1 attached).
3. AWH shall clear the guideway of trees, brush and debris (EXHIBIT 2 attached). Additionally, AWH shall install sewer and erosion controls such as silt fence, drainage protection, and sediment controls.
4. AWH shall work with franchise utility companies to relocate utilities within the guideway (EXHIBIT 3 attached).
5. AWH shall removed designated billboards along the guideway (EXHIBIT 4 attached).

Note: AWH Public Information/Community Relations ("PI/CR") team shall notify residentially adjacent property owners to this scope of work of this upcoming activity. Street sweeping and flagging access shall be maintained throughout construction activities.

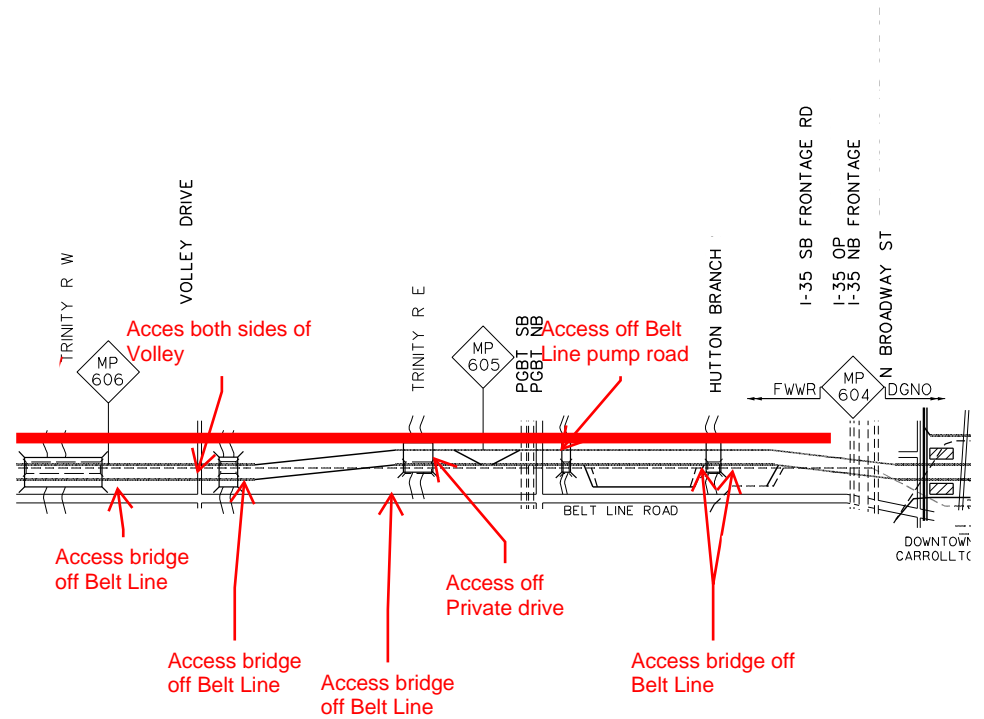

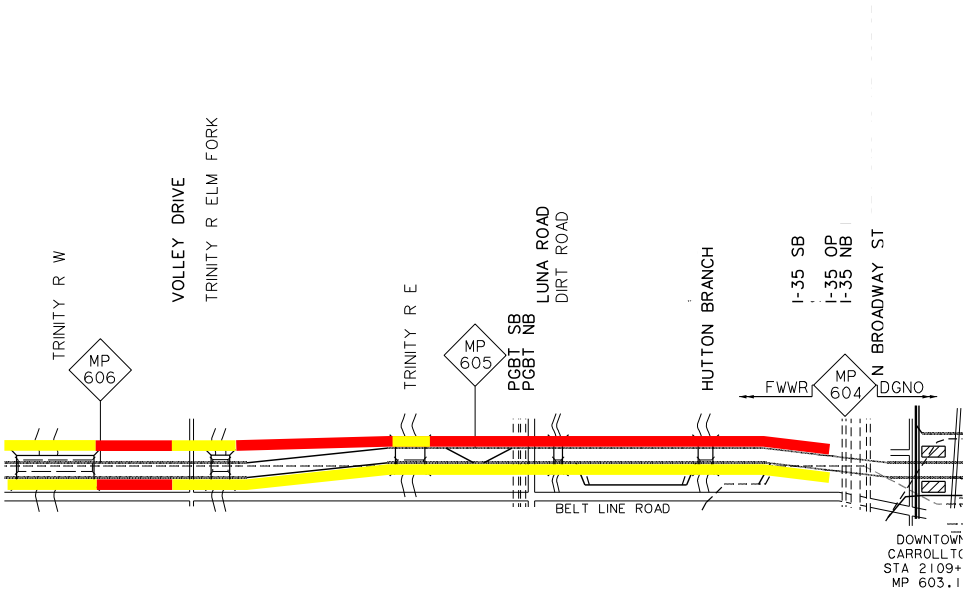

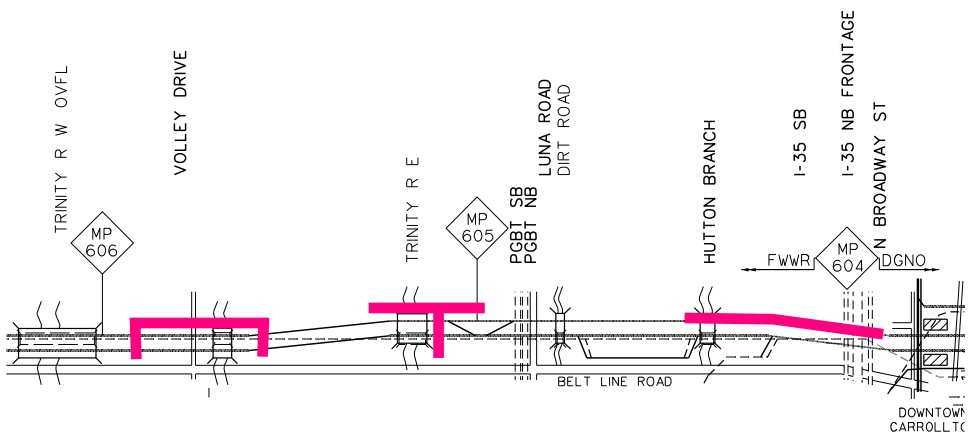
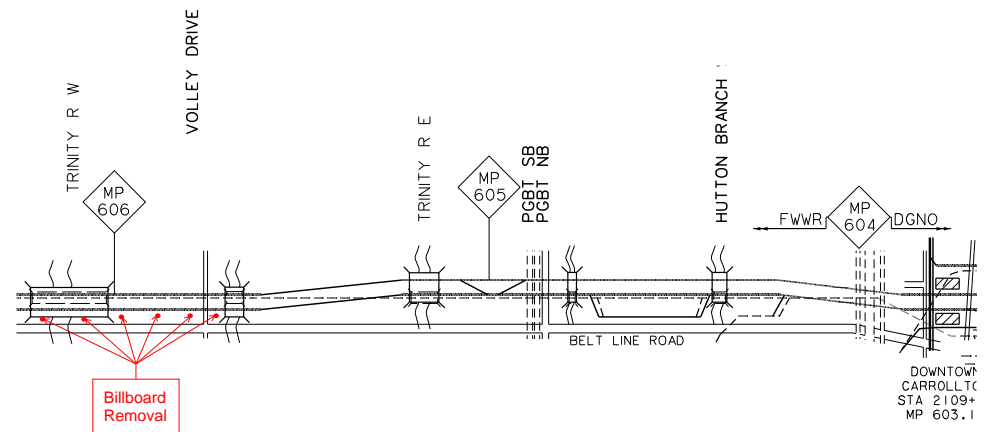
