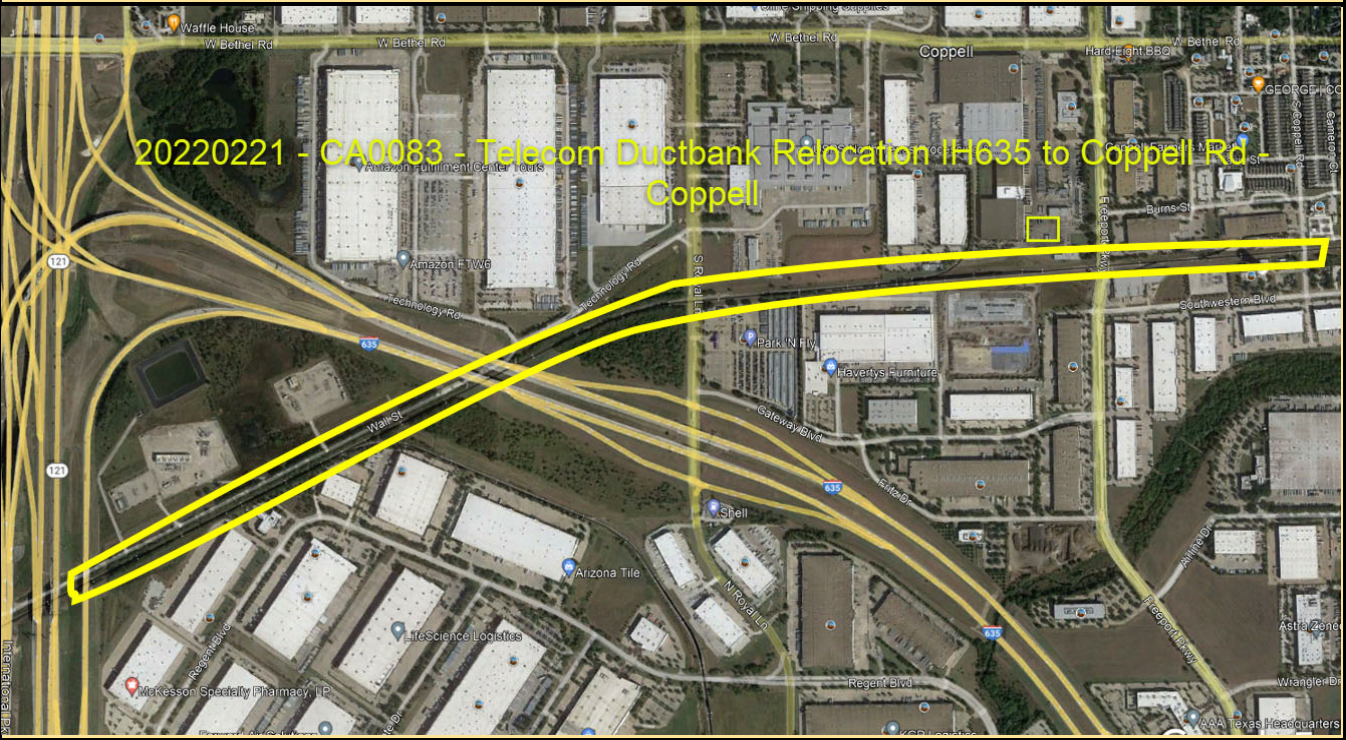

The utility relocation process will be as follows:

1. Fishel crews will mobilize on-site.
3. The area will be secured for residents and workers on-site. Fishel shall use security items such as flagging for guideway access, security fencing, noise suppression, and proper PPE/identification.
4. Crews shall perform their scope of work related to ductbank relocation.
5. Crews shall backfill any exposed area.
6. Crews shall clean-up and mobilize off-site. As a part of the clean-up activities, the contractor will maintain street sweeping required through the scope of their work.

Note: AWH Public Information/Community Relations ("PI/CR") team shall notify residentially adjacent property owners of this scope of work for this upcoming activity. Street sweeping and flagging access shall be maintained throughout construction activities.
