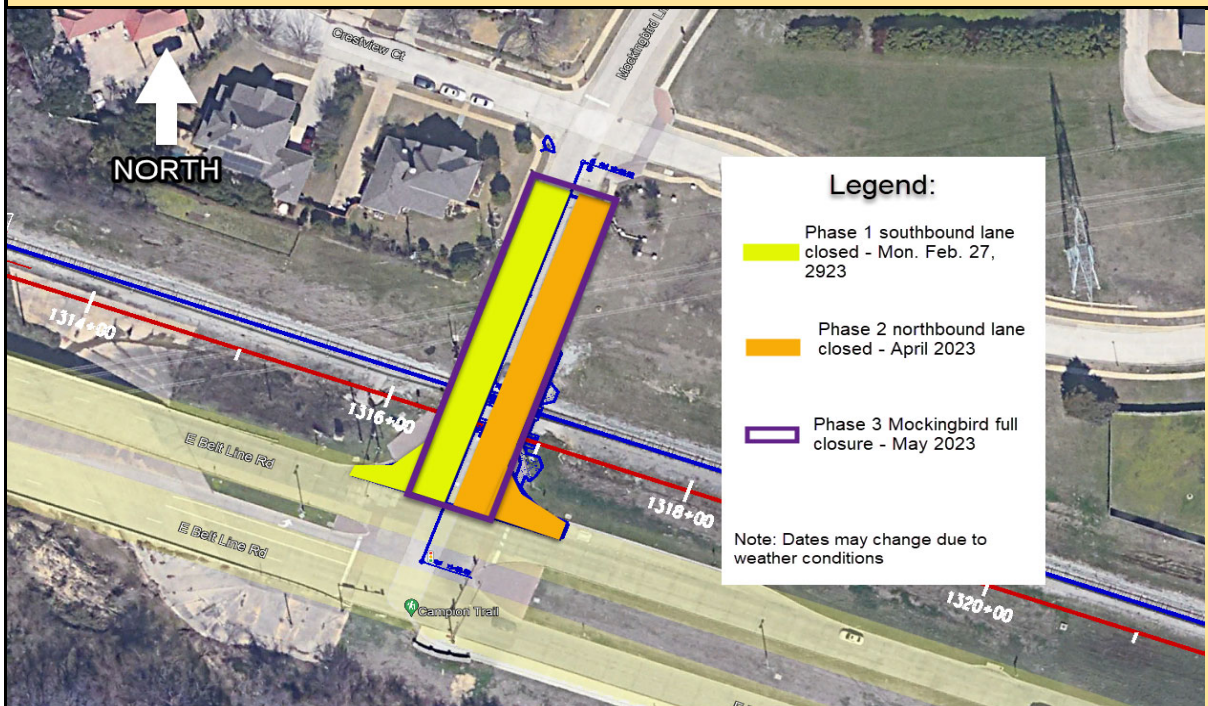
Scope of Construction Activity:

AWH and subcontractors to perform a multi-phase street closure of Mockingbird Ln. for the installation of at-grade rail crossings in the City of Coppell.

Phase 1: Southbound Lane Closure on Mockingbird Ln. is scheduled to start on Monday, February 27, 2023 (No exit out of neighborhood South onto E Belt Line Rd.)

Phase 2: Northbound Lane Closure on Mockingbird Ln. is scheduled to start early April 2023 (No entrance to the neighborhood from E Belt Line Rd)

Phase 3: FULL CLOSURE is scheduled to start mid month during May 2023.



The Mockingbird Ln. Phased and Full Closure rail crossing process will be as follows:

1. AWH/Subs crews to install required traffic signs, arrow boards, cones, closures and street barricades as detailed in attachments.
2. Crews to mobilize on-site to secure the work area for worker, live-traffic, and pedestrian safety.
3. Crews to perform work (demolition, site excavation, concrete pours, rail installation, and back-fill) necessary to complete the Mockingbird Ln. Crossing.
4. The phased work to start Monday, February 27, 2023 and last until mid May 2023.
5. Crews to ensure a completed process, test the area and prepare to open for traffic
6. Crews to clean-up and mobilize off-site. As a part of the clean-up activities, the contractor will maintain street sweeping required through-out the scope of their work.

Note: AWH Public Information/Community Relations ("PI/CR") team shall notify residentially adjacent property owners of the scope of work for this upcoming activity. Community engagement, street sweeping and required flagging shall be maintained throughout construction activities.

Permits Submitted:

1. All work will be within the DART ROW
2. There are not currently any lane/street closures scheduled. Any required closures shall go through the proper process.
3. Temporary Right of Entry Agreement with Fort Worth & Western Railroad company
