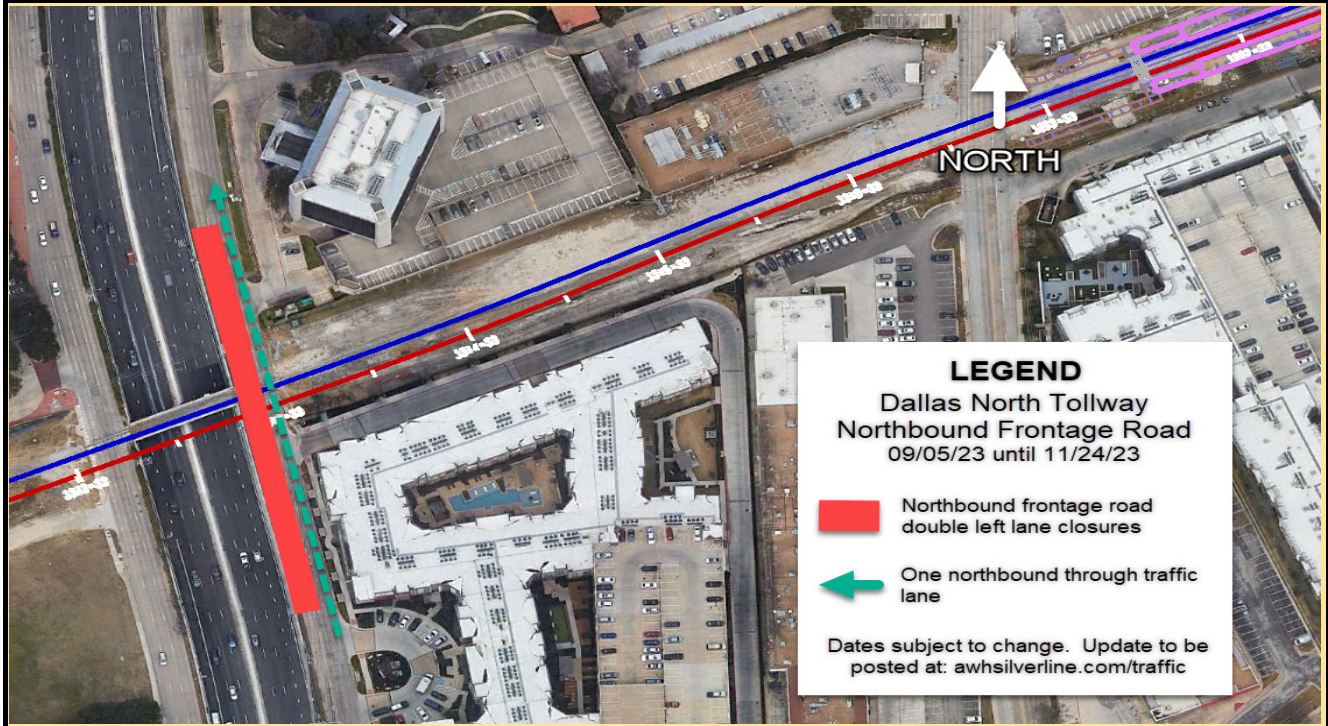

Construction Activity (CA) Details

Construction Schedule:
 - Northbound DNT Frontage Road Lanes: Daily and nightly double northbound left lanes closures - Tuesday, September 5, 2023 until Friday, November 24, 2023 - Monday - Sunday 12:00am - 11:59pm (Double shift 24-hours a day)



The construction activities are as follows:

1. AWH/Subs ("Crews") to mobilize on-site to secure the work area for worker, pedestrian, and traffic safety.
2. AHW/Subs to mobilize crews and equipment (job trucks, hand tools, and large heavy civil machinery) on-site.
3. Day and night Crews to perform saw cutting for drilling abutment shafts, forming/pouring abutment and approach slab, and pouring pavement back.
4. Once the construction is complete they will demobilize from the area to allow for follow-on activities.

Note: AWH Public Information/Community Relations ("PI/CR") team shall notify residentially adjacent property owners of the scope of work for this upcoming activity. Community engagement, street sweeping and required flagging shall be maintained throughout construction activities.
