## **CONSTRUCTION SEQUENCE SUMMARY:**

Archer Western Herzog and subcontractors ("Crews") to start full closure of N. Employee Rd and N. Service Rd. for atgrade rail crossing construction.

### **CONSTRUCTION SCHEDULE:**

- FULL CLOSURE of N. Employee Rd & N. Service Rd. from **7AM Tuesday, April 9, 2024 until 7AM Wednesday, April 10, 2024.** 

The N. Employee Rd. construction activities are as follows:

- 1. AWH/Subs ("Crews") to set-up traffic signage and barricades.
- 2. Crews to mobilize on-site to secure the work area for worker, live-traffic, and pedestrian safety.
- 3. Crews to mobilize heavy-civil construction equipment (heavy-civil equipment, excavators, fleet vehicles, dump trucks, delivery trucks, concrete trucks, etc.) on-site.
- 4. Crews to start construction activities (Demolition, Excavation, Conrete, Sawcut, Rail, etc.).
- 5. Once the Crews are complete with the construction activities, crews will perform final construction cleaning and demobilize from the area.

**Note:** AWH Public Information/Community Relations ("PI/CR") team shall notify adjacent property owners of the scope of work for this upcoming activity. Community engagement, street sweeping and required flagging shall be maintained throughout construction activities.
